### JUDGING CRITERIA:

**MUSCULARITY & BODY CONDITION:** Judges will be looking for fit contestants who display proper shape and symmetry combined with muscularity and over condition. This is not a bodybuilding contest so extreme muscularity will be marked down.

**STAGE PRESENCE & PERSONALITY:** Contestants will appear in board shorts without shirt and barefoot. The shorts must be just above the knee in length and can be just 1inch below the belly button. No spandex or logos permitted except for manufacturer's logo such as Nike. Judges are looking for the contestant with the best stage presence and poise who can successfully convey his personality.

### COMPETITION JUDGING:

**PRESENTATION:** All of the competitors in their height class will be brought out and do their front and back poses as a group. Competitors will then be called out in numerical order individually to walk to center stage face forward and turn to the rear of the stage. **COMPARISON ROUND:** Judges will have the opportunity to compare the competitors in individual groups. At the night show, the winners of each of the 4 classes will be brought out for comparison & scoring for the overall.

**NATIONAL QUALIFIER:** The top 2 in the open in each height class qualify for all the 2018 NPC National Events.
